DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm complex is located west of Beaver Creek Road and east of U.S. Route 40, southeast of Hagerstown near Beaver Creek in Washington County, Maryland. The house and barn are situated on a slight slope, facing east.

The dwelling is a two story, six bay structure built of roughly coursed local limestones. Between the second and third bays from the west end of the house is a vertical seam in the masonry which suggests that the two western bays were added to the main structure. Modified keystones are present above many of the window and door openings. Windows have moderately wide frames secured with wooden pegs and finished with a bead at the inside edge. Two over two light sashes are flanked with louvered shutters.

The main entrance is located in the second bay from the east end of the front elevation. It is framed similarly to the windows and includes a transom. Another entrance appears in the second bay from the west end of the front wall. Both doors are sheltered by a one story, four bay porch supported by chamfered square posts trimmed with curved brackets and small pendants. The porch is reached by a flight of steps and is partially enclosed with a scroll cut balustrade.

Brick flues are located inside each gable end and at the apparently original west end wall of the main section. The roof is sheathed with sheet metal and terminates with beaded barge boards set directly against the end walls. The eaves boxing is trimmed with several courses of cornice molding.

West of the house is a frame bank barn. Between the house and barn is a small log outbuilding or summer kitchen with a large exterior stone flue topped with brick at its south end. Other small outbuildings are located nearby.

The structures are in good to excellent condition and are situated on a tract containing 45.50 acres. Although the building date of this house is not known, the owner reports that the name Adams and a date from the 1850's were penciled in mortar beside the front entrance. The mortar has since fallen away.

STATEMENT OF SIGNIFICANCE

This farm complex consisting of a limestone house, a frame bank barn, a log kitchen and other outbuildings is primarily significant for the regional architectural characteristics it displays. As a working farm which has been productive for a number of years, it is also important for its contribution to the practice of agriculture in Washington County.

Although a date from the 1850's is said to have been found written on the masonry near the main entrance, the appearance of the house would suggest a building date prior to that time, perhaps during the second quarter of the 19th century. Features such as pegged window frames were not used extensively in this area after the first third of the 19th century. Although the seam in the masonry suggests that the western two bays of the house are an addition, the exterior woodwork and masonry is essentially consistent at both sections. The main or original portion of the house has four openings at the front elevation with an off center front door. Houses following this plan are a prominent type in northern Maryland and southern Pennsylvania.

Land records for this farm can be traced back to 1851 when it contained slightly more than 67 acres. On June 6, Joel Newcomer and Sarah Newcomer, David Schlosser and Magdalene Schlosser, Jacob Funk and Caroline Funk, Elizabeth Adams, George S. Adams and Amy Adams, and Jacob R. Adams sold this farm to Henry Adams for \$3,753.75. (IN6/507). The farm remained in the Adams family until May 16, 1914 when John Q. Adams sold it to Samuel C. Kaylor for \$10,000. (102/462, 144/323). It was purchased by George Albert McKee on March 13, 1920. (157/249). It was conveyed to the present owner in 1965 (228/539, 250/573, 427/10).

The property includes part of the grant "John's Lot."
