DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm complex on Dog Street Road appears to date from the 18th century and to reflect Germanic building traditions. The house is built of logs and is sheathed with asbestos shingles. Openings are spaced at irregular intervals in the walls with massive wide frames. A central chimney of brick protrudes from the roof line. A two story two bay stone addition with an inside end chimney extends to the rear.

In a meadow in front of the house is a one and a half story log cabin on high fieldstone foundations built over a spring of water. It has a corner chimney, of brick. Presumably once a dwelling, this building is now vacant. Both the cabin and the main dwelling have doors with raised fielded panels.

Nearer the house are several domestic outbuildings. Also present is a large frame bank barn and related agricultural outbuildings.

STATEMENT OF SIGNIFICANCE

This farm group is significant as an 18th century building complex which reflects Germanic building traditions. The German central chimney house plan may be seen in several 18th century examples in Washington County. The smaller log house may also date from the 18th century although its age cannot be determined without further study.

Dog Street Road which passes by the complex appears to have been one of Washington County's oldest thorofares and a number of 18th or early 19th century structures remain along it.

This complex and others along Dog Street Road are definitely worthy of further study.


