DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This complex of buildings includes a two story, four bay stone house with two stone extensions and a stone grist mill building. Both buildings are constructed of coursed native limestone and have openings with wide wooden frames with ovolo trim. Flat arches of finely dressed stones are present above the doors and windows. The mill has a circular opening in each gable and a large brick chimney. A small stone springhouse is also on the property. The house originally had a two story porch across its front elevation.

STATEMENT OF SIGNIFICANCE

This complex of native stone buildings is primarily significant for its architecture. The house and mill would appear to be contemporary with each other and exhibit exterior features and masonry work typical of the Ca. 1800 period. The mill, presumably for grain represents an important 18th and 19th century industry in Washington County where grain was a prominent crop and water power was readily available.
