DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm complex would appear to date from the third quarter of the 19th century. The house is a two story, four bay brick structure constructed in common bond at all elevations. A series of Victorian brackets are present at the eaves and a gingerbread porch shelters the front door. A group of frame outbuildings are present including a board and batten wash house. The large bank barn was rebuilt in 1952.
