DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story three bay brick house is an L-shaped structure with a two story, four bay wing having a double porch along one elevation. Common bond brickwork is used at all elevations. All windows have six over six pane sashes including those at the attic level. The entrance is elaborate with a diamond pane transom spanning a six panel door and sidelights. Double brick chimneys are located inside the end walls. A large frame dairy barn is present.


