DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farmhouse is a two story, four bay stuccoed structure presumably of stone construction. The two southern bays of the front or east facade are recessed beneath a double porch which is included under the main roof span. An unusual feature of the house is its exterior stone chimney which has been topped with brick. Windows have two over two pane sashes.
