
BUILDING DATE: mid 19th century (pre-1862)

116 West Chapline Street is a north-facing, symmetrical, two-and-a-half-story, three-bay, frame, freestanding, residential structure on a stone foundation. Set directly at the public-right-of-way, the siding on the west elevation of the building has been removed, thus exposing its log construction. The side-gable roof is sheathed with standing-seam metal, has an exterior endwall cinderblock chimney, and open eaves. The east-bay entrance is protected by a shed-roof, open porch that runs the length of the building and is supported by squared posts connected by a slat rail. Windows are set in wide wood frames and are double-hung, two-over-two sash. The building has a one-story rear addition.

A building of the same configuration is noted on the 1877 map of the town as being owned by Highberger. The 1922 Sanborn notes the extant dwelling without its addition as 217 West Chapline Street.

The building is within the Western Maryland Geographic Organization, the Development Period of Agricultural-Industrial Transition, and falls within the Historic Period Theme of Architecture, Landscape Architecture and Community Planning.
