DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

St. Lukes Episcopal Church was built in 1837 and remodeled in 1939. It is a one story, brick building, three bays long and three bays wide. Common bonding was used at all elevations. In the entrance gable wall above the door is an arched topped window. Its form outlined by a double course of header bricks. Other windows are rectangular with multi-pane modern sashes and no masonry arch work at their tops. A brick belfry appears to date from the 20th century.


