DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This complex consists of a brick veneered house possibly of log construction, one and a half stories high and four bay wide with a two story, four bay stone extension to the rear. Also present is a ruined log cabin with a stone addition. Both of these secondary buildings are constructed over a spring. A large frame bank barn is included in the group as well. Part of one gable of the main house is sheathed with vertical board siding. A deep overhanging porch which extends along the front elevation is included under the main roof span. A German sided overhang is attached to the second story of the stone section.




