DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This group of buildings consists of a two story three bay house sheathed with imitation brick composition siding and a small log cabin, three bays wide which serves now as an out kitchen. Its logs are joined at the corners with the inverted "V" notch typical of the area. Just below the buildings is a spring which pours out at a steady rate along the edge of Pleasant Valley Road.


