DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm group situated along Unger Road includes a two story three bay house sheathed with asbestos shingle siding, a frame bank barn and modern concrete block dairy barns. The house has a wing which extends to the rear. Windows have architraves with pointed top pieces which are typical of the late 19th century. Two over two pane sashes have arched upper sections. It is possible that the siding conceals log construction.


