24 West Water Street is a south-facing, vertically massed, symmetrical, two-and-a-half-story, three-bay, freestanding, frame residential structure resting at grade on a stone foundation. The elevations are covered with modern manufactured siding and the side gable roof is covered with grey slate. The fenestration consists of single, rectangular, wooden sash, double-hung, two-over-two windows. Each windows has shutters. The eastern-bay entrance holds a replacement door and is protected by a hipped-roof, open porch that runs along the facade of the building. The porch roof is supported by iron posts.

Outbuildings in the rear of the house consist of a shed and a modern garage.

The building is set on original lot 71, a vacant lot that was owned by George Greager, according to the 1814 plat of the town. No building appears on this lot, then owned by H.W. Lyday, on the 1875 map either. However, the extant building does appear on the 1916 Sanborn as 204 Water Street. The map notes that there was a confectionery in the western portion of the house and that the front porch was originally just a portico over the front door. Furthermore, a washhouse is located behind the main house. This structure had been demolished by 1923, according the 1923 Sanborn.

The building is within the Western Maryland Geographic Organization, the Development Period of Industrial/Urban Dominance, and falls within the Historic Period Theme of Architecture, Landscape Architecture and Community Planning.
