20-22 South Main Street is a raised, east-facing, horizontally massed, symmetrical, two-and-a-half-story, five-bay, freestanding, frame residential structure resting on a brick foundation. The focus of the building is its open eastlake portico, and its steeply pitched front intersecting gable. The building, which is sited directly at the public right-of-way, has manufactured siding. The intersecting gable roof is covered with artificial roll, and has open eaves and gable returns. Fenestration consists of single, rectangular, wooden sash, double-hung, two-over-two windows. There is a paired, double-hung, one-over-one window in the front gable. The entrance is in the center bay and is protected by an open, eastlake portico.

The building is set on original lot 3, a vacant lot that was owned by Benjamin Huntman, according to the 1814 plat of the town. A post office on the lot owned by S. Bustidol(sp?) appears on the site on the 1875 map. According to the Smithsburg Historical Society (SHS), the small building was a log structure that was demolished in 1898 for the construction of the extant building, which was built by the Barktels(sp?). The extant building is noted on the 1916 Sanborn as 106 Main and had a barber shop in it and a kitchen in a separate outbuilding. The 1923 Sanborn notes a store in the basement. According to the SHS, a cobbler's shop was housed in this structure in the 1920s and 1930s, and a barbershop occupied it in the 1930s and 1940s.

The building is within the Western Maryland Geographic

Organization, the Development Period of Industrial/Urban Dominance,
and falls within the Historic Period Theme of Architecture,
Landscape Architecture and Community Planning.
