DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This building is located 1/4 mile west of Rockdale Road and approximately 3/4 mile north of U.S. 40 in Washington County, Maryland. It faces south and is situated directly over a small stream which emerges from a nearby spring. It is part of a complex of farm buildings which includes a large brick dwelling, ruins of a stone end barn and several outbuildings.

The structure contains two bays and is built of coursed local limestone. It is 1-1/2 stories in height and shows evidence of having had an internally-placed chimney in its east gable. Openings consist of a door and window located at the south front and one window on the north side of the house.

The board and batten door is relatively wide. It is framed very simply with boarding at the jambs and lintel and a limestone sill. The window opening is treated similarly but does have a board sill. The framing is joined by nails. There is no decorative stone work associated with these openings.

The roof is covered with corrugated metal and there is no cornice or finishing molding at the eaves.

The interior of the structure contains one room. Below the main floor is a vaulted brick chamber through which flows the small stream.

This structure originally could have been used as a dwelling or as a service building. There is no substantiated date for it and it does not appear to have been documented in any existing records. The use of coursed limestone for the walls involves a process where time must be taken to shape the stones. Such a lengthy method would not have been used in frontier days. The use of nails rather than pegs at the windows and door would also suggest a somewhat later date than might otherwise be expected. The structure probably dates from the first quarter of the 19th century.

The building is unaltered and is in fair condition. The large brick dwelling house on the property is considered in form WA V-004.

STATEMENT OF SIGNIFICANCE

The area of significance of this small stone cabin is its architecture. Whether it was used as a dwelling or as a service building, the structure is an example of a primitive type of building. Small stone structures like this one may have been used as dwellings at an early date. Similar buildings of stone were common as dwellings in the north of Ireland and the idea for such structures may have been transported to Maryland by Scotch-Irish settlers. Although a number of settlers in Washington County were Scotch-Irish, the stone cabin was probably not a major building type in early settlement days. The log cabin is more frequently found today and was probably used more often in frontier times.

Some stone cabins do survive today. Most are now used as out-buildings and often as spring houses because many such structures were erected directly over the water source. They may be distinguished from buildings constructed specifically as spring houses by the presence of a fireplace and windows.

The intended original use and the date of this structure cannot at this time be determined.
