DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This property is near the site of a late 18th and early 19th century grist mill. Remaining now are two dwellings that were associated with the complex. The larger of the two houses is considered in survey form WA-V-011. Both buildings are shown in a Ca. 1900 photograph of the complex which includes a frame barn as well. It indicates that the main house was enlarged from one and a half stories as it appears in the picture to the two full stories it now has. The smaller house, a secondary dwelling is a one and a half story, four bay structure with a deep overhanging porch along its entire front elevation. Since the old photograph was made, two dormers have been added to the front slope of the roof. No exposed evidence of the mill remains.


