DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>This structure is located just east of the junction of Maryland Route 56 and the Big Spring-Clear Spring Road, approximately 1/2 mile east of Big Spring. It stands on the south side of Route 56, facing north.</p> <p>The house is a two-story, three-bay log dwelling covered with shingles. A one-story bay addition encased with siding is attached on an axis with the west end of the main structure. Both sections are white with dark green trim. Small brick chimneys with corbeled caps are located inside each gable end of the main section. A large exterior stone chimney is located at the gable of the one-story section.</p> <p>The foundation of each section is of uncoursed local limestone. In both sections, the structural material is covered with siding. However, the thickness of the walls in the main section indicates log construction while the somewhat thinner walls of the one-story section suggests a frame structure.</p> <p>Exterior woodwork of both sections appears to date from the early 20th century. A modified architrave is present over each window. Simple boxing finishes the eaves. The door is framed in a similar manner to the window and has no transom or sidelights.</p> <p>A porch probably dating from the early 20th century extends across the two-story section of the house. It is supported by doric columns which rest on square brick bases that also anchor the floor and balustrade.</p> <p>There is no known date indicating the year that this house was built. The presence of a log wall between the one and two story parts indicates that the main section was built first.</p> <p>The structure is presently used as a private residence and is on property containing 3.5 acres. The house is not now in danger of great alteration or destruction.</p>

STATEMENT OF SIGNIFICANCE

The area of significance of this structure is its architecture. Although the exterior has received extensive alteration, the basic structure seems to be in tact. The large stone exterior chimney located at the west end of the one-story section of the house appears to be of a type which usually dates from the late 18th or early 19th centuries. It is possible that an earlier log building once stood where the one-story section is now located.

It is difficult to date the two-story log section because of the numerous exterior changes that it has received. It does appear to be a 19th century structure and may date from before 1850.

This house has no great architectural value but it is representative of a type of dwelling frequently found in Washington County. Such houses are often built of log and have irregular floor plans. Most log structures have been encased with siding or other type of exterior covering.
