This two story, three bay house would appear to be of log construction. It is thoroughly covered with imitation brick composition siding. An interior chimney of concrete block extends from the roof line. Most exterior features of this house suggest the late 19th or early 20th century. Its actual structure which could not be observed may be older.




