The Ernstville - Big Pool area is predominantly a late 19th century community which apparently developed along the Western Maryland Railroad, The C & O Canal and the Potomac River. Most of the houses appear to be of frame construction or sided log. A large frame warehouse structure is located near the railroad tracks.
