224 Cumberland Street is a south-facing, two-and-a-half-story, three-bay, frame, freestanding, residential structure. The building, which is set directly at the public-right-of-way, rests on a stuccoed foundation and is covered with manufactured siding. The walls appear to be very thick and may indicate log construction. The side-gable tin roof has one chimney. A simple, eastlake porch extends across the front of the building and protects the east-bay door and its transom. Windows are double-hung, two-over-two sash. The structure has a two-story ell.

According to a history of the site prepared for the Clear Spring Historical Society by Lisa Poole, this property was originally part of lot 6 that was sold by Martin Myer in 1832 to George and Susan Keefer (Liber NN, Folio 441). Although there is indication in a deed that was executed the following year that a house had been erected on the property, this has not been conclusively proven. However, an 1857 deed does state that a two-story, weatherboard house was part of the property and a newspaper advertisement from the Hagerstown paper (Jan. 1, 1856) confirms this. It states that along with the house, there was a stable, carpenter's shop and a well. The house is indicated on the 1877 map of the town as being owned by J. Sword. The building is also shown on the 1922 Sanborn as 221 Cumberland Street. The map also notes a long, one-story building directly behind the house.

The building is within the Western Maryland Geographic Organization, the Development Period of Agricultural-Industrial
