114-116 Cumberland Street is a south-facing, horizontally massed, two-story, four-bay, frame, attached, structure that was built in two stages. The western two bays are the oldest. The building, which is set directly at the public-right-of-way, is covered in manufactured siding that is patterned to look like brick. The structure has a corrugated metal, side-gable roof with one chimney in the western portion and a shed roof in the eastern portion. A one-story bay window has been added to the front facade in the west bay. The entrance in the western section has an oak door that is obscured by a storm door, and has a two-light transom. The entrance in the east section has a glazed door topped by a single-light transom. Windows on the first floor of the two sections are a combination of single-pane fixed sash and double-hung, one-over-one sash. All windows on the second floor are double-hung two-over-two.

The 1877 map of Clear Spring shows the western portion of the building and notes that it was owned by J. Sosey. This section is also shown on the 1922 Sanborn which numbers the building 117 Cumberland and notes that it was occupied by a store at that time. The building is now residential.

The building is within the Western Maryland Geographic Organization, the probable Development Period of Agricultural-Industrial Transition (western portion) and Modern Period (eastern portion), and falls within the Historic Period Themes of Economic; and Architecture, Landscape Architecture, and Community Planning.
