26 Cumberland Street is a south-facing, horizontally massed, two-and-a-half-story, six-bay, log encased in brick, freestanding, residential structure. The building, which is set directly at the public-right-of-way on a stone foundation, is laid in flemish bond that has been painted red. The building has a tin, side-gable roof with massive brick chimneys at either end and a box cornice. An eastlake porch with a hipped roof extends across the center bays. The entrance, which is in a center bay, is composed of a glazed door with two wood panels. Windows are double-hung, six-over-six sash. The building has a one-story rear addition.

According to a history of the site prepared for the Clear Spring Historical Society by Hilda Cushwa, this property was originally part of lot 46 that was sold by Martin Myer in 1824 to William Harley (Liber GG, Folio 731). The building was occupied in the 1830s by Dr. James Beatty who kept his office there. During his tenure, the building was already encased in brick. The structure is first noted on historic maps in 1877 where the owner is given as Mrs. Newcomer. The 1922 Sanborn map indicates the structure with a porch extending the full length of the facade, and numbers it 106 Cumberland.

The building is within the Western Maryland Geographic Organization, the Development Period of Agricultural-Industrial Transition, and falls within the Historic Period Theme of Architecture, Landscape Architecture, and Community Planning.
