221 Cumberland Street is a north-facing, two-story, three-bay, frame, residential structure that is attached to an identical structure. The building, which is set back from the public-right-of-way, rests on a stone foundation and is covered with manufactured siding. The wide, front-gable, tin roof has one chimney in the rear. Its decorative bargeboard has been removed. A deep, recently rebuilt portico is located in the center bay and protects the entrance which has been completely remodeled. The windows are modern, replacement, double-hung, one-over-one sash with shutters.

According to a history of the site compiled for the Clear Spring Historical Society by Lisa Poole, this building is on original lot 9 which was first sold by Martin Myers to Jonathan Nesbitt in 1824 (Liber GG, Folio 896). The structure is noted on the 1877 map of Clear Spring as being owned by George Mish. The 1922 Sanborn numbers it 245 Cumberland Street.

The building is within the Western Maryland Geographic Organization, the probable Development Period of Agricultural-Industrial Transition, and falls within the Historic Period Theme of Architecture, Landscape Architecture, and Community Planning.
