Milestone No. 131(135) marks Mason and Dixon's 131st horizontal mile west of the northeast corner of Maryland, the beginning of their 230.228-mile West Line, later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. It is an original milestone of 1767, quarried and carved in England of oolitic limestone, is in good condition, unaltered, and now stands about 10 inches above ground at its original site, preliminarily surveyed in 1766, monumented the following year, and reset more securely in 1902 during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. It is significant on the national and state levels primarily as one of 135 original Mason and Dixon monuments in the thematic group series of some 248 markers still defining the West Line. Locally, as one of 48 of these original monuments marking the present Washington/Franklin-Fulton county boundary, it is also significant as one of a diminishing number of objects and structures with a visually identifiable relationship to the colonial and Civil War heritage of these counties.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Milestone No. 131(135) marks Mason and Dixon's 131st horizontal mile west of the northeast corner of Maryland, the beginning of their 230.228-mile West Line. It is an original milestone of 1767, in good condition, unaltered, stands about 10 inches above ground at its original site, preliminarily surveyed in 1766, monumented the following year and reset more securely in 1902 during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary.

The area here is hilly deciduous woodlands interspersed with orchards, sparsely settled. The site is within Election District 5 of Washington County, MD, and Bethel Township of Fulton County, PA; on an east slope of a hill in Sawmill Hollow; about 1½ miles north-northeast of the scattered settlement of Harvey, MD; about 3900 feet due east of Rice Road/Hill Road (T-301) at the Line; about 2000 feet north of Resley Road; at a point about 150 feet west of a small stream and about 16 feet south of the old Columbia Gas pipeline. It is partially buried, nearly covered with moss and difficult to find. It cannot be seen from any road or from the pipeline, well protected by the camouflage (so much so, it could easily disappear into oblivion from neglect).

The milestone, as with all original Mason and Dixon West Line monuments, is an oolitic limestone post with a low pyramidal top, quarried and carved in England, and said to have originally measured about 12 inches square by about 4 feet or more in length, cut to stand about 3 feet high with the base left rough-cut for setting into the ground. The distinguishing embellishments are the vertical fluting with horizontally-fluted margins on all four sides, and the Roman capital letters P on the north side facing Pennsylvania and M on the south side facing Maryland, each V-sunk in the center of a plain shallow circle panel near the top. Reset in 1902 to stand presumably about 1½ feet high, it is now about 10 inches high, measures about 12½ inches on the north and south sides by about 11½ inches on the east and west sides. ^{and circle panels} The letters ^{are} clear ^{and apex} but ^{and apex} the M is chipped; patches of fluting and margins remain; the top planes ^{are} well preserved and with some fluting remaining; there are chips at the top corners ^{and all four sides are mottled by moss.} particularly the top southeast;


