DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three bay, two story house stands on the west side of Conococheague Street, facing east. It would appear to be of log construction and probably dates from the late 19th century. The walls are sheathed with asbestos shingle siding. The windows are long and narrow with two over two pane sashes. The roof is sheathed with standing seam sheet metal and a brick chimney extends from inside the south end wall. There is a two bay entrance porch with a hipped roof. It is supported by small round columns.
