This two story, three bay house is of log construction and probably dates from the mid 19th century. It is sheathed with German siding. Windows have two over two pane sashes with plain architraves. The main entrance is located in the center bay of the front or east elevation. The roof is covered with standing seam sheet metal. A patch near its center could indicate the location of a former chimney.
