Description

Part of a row of three story painted brick late 19th century Italianate commercial/residential structures. It has original storefronts and a massive bracketed cornice. Attached is a two story, two bay section with Flemish Bond brick, dating from Ca. 1820, altered early 20th century. This is one of several Williamsport buildings with notable intact storefronts from the Ca. 1900 period. In 1910, this building is shown as a meat market on the Sanborn map. According to local informants, the Williamsport Savings Bank occupied the building from about 1915 through the 1920s.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building begins a row of three story Italianate commercial-residential structures which continues to the end of the first block of the west side of North Conococheague Street. It is a four bay structure built of brick, painted grey. Windows have single pane double hung sashes beneath segmental arches. The first story has two entrances: One at the southernmost bay which leads to the upper stories and one which is part of a store front which appears to be original.

The store front is a tripartite area consisting of two elliptically arched plate glass windows flanking a similarly arched recessed entrance. The store front is trimmed with molded recessed panels and topped with a cornice supported by decorative brackets.

At the second story facade's south end is a projecting window bay supported by brackets matching those used for the store front cornice.

The top of the building is crowned with a deep overhanging cornice and a series of alternating small and large brackets.


