Description

Central section of a late 19th century painted brick Italianate commercial/residential row. Three stories, three bays with original storefronts and a massive bracketed cornice. One of several Williamsport buildings with notable intact storefronts from the Ca. 1900 period. During the 1910s and 1920s Downs' Drugstore was located here according to Sanborn Insurance maps and local informants.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three bay, three story brick building forms the central part of a series of Italianate commercial and residential structures on the west side of the first block of North Conococheague Street. The surface of this structure is painted red. At the first story it has an original store front consisting of plate glass windows flanking a recessed entrance. At the tops of the store windows are sections of decorative leaded glass. To the north of the store front in the end bay is the entrance leading to the other parts of the building. It has a four panel door beneath a segmentally arched transom. The hipped roof door hood is modern.

The building above the first floor is relatively plain. Windows have single pane double hung sashes under segmentally arched brick heads. An overhanging cornice with heavy brackets crowns the building.


