This house is a two story with attic and basement (possibly log) six bay residence with a two story shed roof two bay frame addition to the west that serves as a commercial function. It is situated on the north side of West Potomac Street and faces south.

The house has a standing seam tin roof, is sided with aluminum siding and has arched top one over one sash. There is a three bay porch on the front of the house with a shallow hip roof. The exterior work has mostly been done in the 20th century but the original structure is of 19th century construction.


