DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story with attic and basement, three bay stone residence with a one story, three bay brick wing attached to the west side. The structure is situated on the north side of East Potomac Street facing south.

It has a standing seam tin roof, windows are six over six double hung sash, the stone work is coursed with detailed block design mortar joints. The brick addition front is Flemish bond. The window, window, door arrangement is reflective of both parts with the door on both sides in the east position. Both of these sections appear to have been built in the 18th century.
