Situated on the north side of West Salisbury Street facing south is this two story, three bay, side entrance, frame residence now being used to store lumber products. It has a standing seam tin roof, three over one double hung sash, a door in the east position, and is covered with asbestos siding. This building was constructed in the late 19th century.


