Situated on the north side of West Salisbury Street, rear of North Vermont Street facing south is a two story, two bay frame structure. It has a gable end presented to the road as a major facade. It is covered with asbestos siding and has two over two double hung sash. A porch and roof deck extend across the front. This structure was probably built in the first quarter of the 20th century.


