Situated on the north side of West Salisbury Street facing south is a one story log house with four bays. It has a standing seam tin roof, aluminum siding, nine over six double hung sash and a side entrance door in the east position of the south facade. There is a three bay front porch with a shed roof. The foundation is limestone. This building was constructed in the early 19th century.


