DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the north side of West Salisbury Street facing south is a two story, four bay log house. It has a standing seam tin roof, compositon shingle siding, two over two double hung sashes. A two bay, hip roof covers the two front doors. One door was added in the 20th century to cut this single residence into two rental units. This log structure dates from the 19th century possibly the first half.
