DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the north side of West Salisbury Street facing south is a one and a half story, three bay log structure. It has a standing seam tin roof, asbestos siding and three over one light double hung sash. In the 1920's or 1930's the upper story had the front roof raised to give full height to the second floor. A two bay front porch with hip roof covers the door and window. The log house was probably built in the 19th century.
