Situated on the north side of East Salisbury Street facing south is a two story, three bay, brick residence turned into a club. It has a three tab composition shingle roof, a white brick veneer front with all openings on the second floor completely closed. It sits on a limestone foundation and may have been built in the 19th century, but the alterations leave few clues concerning date for a quick exterior inspection.


