Description

Three story, two bay brick Italianate commercial/residential building, late 19th century. Altered storefront. During the early 20th century, there was a butcher shop in this building. In the 1910s through 1930s it was a fire hall and jail, according to local informants. It represents Williamsport's late 19th century urban character.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is a three story, two bay Italianate mixed commercial and residential structure. At the first story is a modern store front which probably replaces an original commercial entrance. Windows have single pane double hung sashes with segmentally arched heads. The building is covered with an overhanging bracketed cornice which is shared with the adjoining building to the north. The building would appear to date from the late 19th century.


