DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building forms the central section of a row of town houses on the east side of North Conococheague Street. The houses would appear to date from the early to mid 19th century with extensive alterations dating from the late 19th century. It is a two story structure plus a mansard with dormers. The walls of this section have been painted green. The facade displays Flemish bond brickwork, one of the indicators that the building was an older house renovated. Windows have late 19th century segmental arches above single pane double hung sashes. There are two entrances in the five bay facade, in the first and third bays from the north end. The window and door placement at the first story is quite irregular. Above the entrance is a semi hexagonal projecting wooden window bay. Gabled dormers are located in the mansard. The mansard is covered with slate placed in an imbricated pattern.
