Two story, three bay brick commercial/residential building with a mansard roof and gabled dormers. Late 19th century. Original storefront. There is also a semi-hexagonal projecting bay. This building contained Bowser's Confectionery in the early 1900s and Sammy's 10 Cents Store in the 1930s.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the east side of North Conococheague Street facing west is a two story with mansard roof, three bay, brick shop/residence. It has slate covering the mansard out of which projects three dormers. The second floor has a semi hexagonal projecting bay with flat top windows. The shop is in the southern end of the west elevation. The other door and window heads are round arched. It was built in the late 19th century.
