Situated on the east side of North Conococheague Street and facing west is a two story, three bay, early 19th century brick dwelling converted to commercial/residential. The Flemish bond brick front has had a 20th century window put in the first floor and a recessed front door behind an arched brick header opening. It has a standing seam tin roof and one over one double hung sash.


