DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the east side of North Conococheague Street and facing west is a two and a half story, two bay, brick dwelling. It has a stepped parapet wall hiding the roof. The walls are laid in common bond brick and the windows have two over two double hung sash. Built into a bank, the first floor walls are built out of limestone and the front is of brick. This structure was built in the 19th century.
