DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the south side of West Potomac Street facing north is a two story, three bay brick house probably dating from the early to mid 19th century. Bricks forming its front wall are laid in Flemish bond. Windows have modern single pane sashes beneath flat arches of brick. The main entrance has a three light transom and is located in the eastern most bay of the front elevation.
