DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the south side of West Potomac Street and facing north is a two story, four bay house built of stone with an added late 19th century brick facade. The stone portion of the house could date from the late 18th or early 19th century. What is apparent from the street, however, is a brick facade with segmentally arched openings. Windows have single pane double hung sash and Victorian brackets trim the eaves. The main entrance is located in the east central bay.
