DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Situated on the south side of West Potomac Street and facing north is a two story, five bay brick structure dating from the early 20th century. The walls have been painted. The house has a projecting cross gable with a semi hexagonal projecting window bay. Windows have single pane double hung sashes beneath segmental arches. The panes are trimmed with stained glass squares around the perimeters. The main entrance is located in the third bay from the east end. The roof is covered with standing seam sheet metal.


