DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house, located on the west side of North Vermont Street is a one story, five bay log building, probably dating from the late 18th century. Its walls are covered with asbestos shingle siding. The north bay may be an addition. Windows have two over two panes with arched upper sashes. These windows are not original. They are held within original wide frames with ovolo trim. The main entrance is in the central bay. The roofing material is standing seam sheet metal. Brick chimneys with corbels at their tops are located inside the south end wall and at the interior between the first and second bays from the north end. There is a small shed roofed entrance porch. The house appears to be in good condition.


