DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two part house is located on the south side of West Salisbury Street, facing north. The older section of the building is a two story, three bay structure, possibly built of logs and covered with aluminum siding. Windows are small in relation to wall area with two over two sash at the first story and older six over six sash at the second story level. The entrance is located in the east bay of that section. The roof is covered with standing seam sheet metal. A brick chimney is located inside the west end wall. Attached to the east end of this structure is a two story, two bay extension of frame or log construction. It too is covered with aluminum siding and has a standing seam sheet metal roof. The older part of this building would appear to date from the early 19th century.
