This house is located on the west side of North Artizan Street. It is a two story, four bay hip roofed, brick double house which appears to date from the early 20th century. Windows have single pane sashes with segmentally arched heads. A hip roofed dormer window is centered above the front wall. There are two central front doors, each with a single pane transom. A hipped roof porch extends across the front of the building. Two small brick chimneys extends from inside the end walls. The house is in good condition.
