DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is a two and one half story log structure resting on high rubble foundations. Its walls have been covered with asbestos shingle siding. The foundations are nearly a full story in height at the front elevation, and there is an entrance and a window in the front foundation wall. Windows at the main story have single pane sashes while those at the upper half story have three over three light sashes. The main entrance is located in the center bay of the front elevation. Sheet metal covers the roof. The house appears to be in good condition and probably dates from the mid to late 19th century.
