DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is located on the west side of South Artizan Street. It is a two story, four bay log structure covered at the front elevation with asbestos shingle siding.

There is bevel topped siding on the end walls. The windows are small in relation to wall area and have two over two pane sashes. The main entrance is located in the third bay from the south end and includes a two light transom. A brick chimney extends from inside the south end wall. Sheet metal covers the roof. The house is in good condition, and would appear to date from the late 18th or early 19th century.
