DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house, located on the west side of South Vermont Street is a one and a half story, three bay log house covered with composition siding. It also has a log addition. First story windows have two over two pane sashes, while those at the upper half story have six lights. The main entrance is located in the north bay of the front wall. It contains no transom and is not aligned with the upper level windows. The roof is covered with sheet metal. A brick chimney with a corbel at its top is located near the center of the house. A three bay hip roofed entrance porch is supported by turned posts. The house appears to be in fair condition and could date from the mid 19th century.
