DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house, located on the east side of North Vermont Street is a one and a half story, three bay frame or log structure covered with narrow gauge siding. Windows have two over two pane sashes at both the first and upper story levels. The entrance is in the center bay. A brick chimney extends from the interior of the house, near its center. A shed roofed porch supported by chamfered square posts extends across two of the front bays. The house appears to be in excellent condition. It may date from the late 19th century.




